



“Jingle Jangle Jog” Contest

07 to 27 December 2017

TERMS & CONDITIONS

1. The online contest described in this document ("**Contest**") is organised and promoted by Everbilt Developers Pte Ltd (as property manager of Wheelock Place) ("**Wheelock Place Management**") for the mall known as "Wheelock Place" ("**Wheelock Place**").
2. By participating in the Contest as players, the players agree to be bound by the terms and conditions of the Contest ("**Terms**") as set out below. Wheelock Place Management reserves the right to change any of the Terms (including but not limited to the dates of the Contest and the prizes or their value) at its sole discretion without notice.
3. Except as otherwise specified herein, the players agree that the decision of Wheelock Place Management on all matters relating to the Contest is final, conclusive and binding on all players and no correspondences will be entertained.

The Contest

4. The Contest named "Jingle Jangle Jog" is a online game available during the period from 7 December 2017 to 27 December 2017 ("**Contest Period**") where players are required to collect as many Christmas presents whilst avoiding obstacles before they are knocked out in the online game.
5. Each player is required to register their details to submit their score to the daily leader board. Compulsory details required for registration are:
 - a. Full Name (As per their NRIC for verification purposes in a prize claim)
 - b. Email Address
 - c. Mobile Number
6. Only the top 3 players whose names are in the daily leader board will be entitled to a chance to win \$200 worth of Wheelock Place Gift Vouchers each.
7. There will be a total of sixty three (63) winners throughout the Contest Period. For each day during the Contest Period, the top three (3) players with the highest score on the leader board at the end of each day will be the winners.
8. There will be a total of twenty-one (21) daily rounds of games within the day during the Contest Period. To join each day's daily round, simply register and play the game before the cut-off date/time as stated below.

9. The official time is Singapore time. Any score submitted after the cut-off time will not be considered for that daily round.
10. Scores published on the leader board are subject to verification and do not constitute that the player has won a prize. Winners will be announced weekly on the Wheellock Place website (What's On) according to the following schedule:

11. In the event where more than one (1) player achieves the same score, players will be ranked according to the time they achieved the score.
12. Each Player is only allowed to one (1) winning prize during the entire Contest Period.

13. All winners will be notified (“winners notification”) within a reasonable time via their registered email address.
14. All winners must acknowledge the email (“winners notification”) prior to the collection of their prizes from Wheelock Place Management’s Office at 501 Orchard Road #11-01 Wheelock Place S(238880), from 10am to 5pm.
15. Each prize must be claimed by the winning player in person from the above mentioned office, at the stipulated date and time in the winners notification email.
16. For collection of the prize, winners are to present their NRIC for verification purposes where the registered “Full Name” must match their NRIC or the prize will be forfeited. Additional verification may be required as deemed fit and necessary by Wheelock Place Management.
17. Prizes are not redeemable for cash, credit or otherwise. Refunds and/or exchanges will not be entertained. If prizes are not collected by the winners by the Collection Expiry Date as specified in the winners notification, Wheelock Place Management reserves its right, in its sole discretion, to:
 - (a) award any part or all of the prizes to any substitute winners of the Contest where Wheelock Place Management’s decision shall be final and conclusive; and/or
 - (b) donate any of the prizes to the Community Chest or other charitable organizations as deemed fit by Wheelock Place Management.)

To the extent permitted by law, by participating in the Contest, each player releases the Wheelock Place Management, Everbilt Developers Pte Ltd, its subsidiaries, affiliates, associates, agents and assigns from, and indemnifies the same against, any liability for loss, cost, expense or damage to person or property suffered and/or incurred arising out of, and/or in connection with, the Contest, and/or the collection and/or use of any prize.
19. Wheelock Place Management reserves the right to verify the validity of all entries and the right to disqualify any participant/player or entrant or winner:
 - b. who submits an entry that is not in accordance with these terms and conditions; and/or
 - c. who has, in the opinion of Wheelock Place Management, engaged in any unlawful or other improper conduct which jeopardises, or may jeopardise, the fair and proper conduct of the competition; and/or
 - d. who has engaged in conduct in entering the competition which is unlawful, fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the competition and/or the Wheelock Place Management; and/or
 - e. any conduct or behaviour which Wheelock Place Management considers undesirable, improper or inappropriate; and/or

In such event, Wheelock Place Management reserves all rights to recover any costs and expenses and/or loss and/or damages and/or compensations from such disqualified persons.

Eligibility to Enter

20. Participation in the Contest is open to all citizens and residents of Singapore above sixteen (16) years of age as of 7 Dec 2017 except:



- f. employees of the Everbilt Developers Pte Ltd and its subsidiaries and immediate families of such employees. Immediate family members include spouses, children, parents, parents-in-law and siblings; and
 - g. public relations, advertising agencies, participating business partners and tenants of Wheelock Place and their staff.
21. Acceptance of a prize constitutes permission for Wheelock Place Management to use the winner's name and/or likeness for advertising purposes without further notice or compensation, unless prohibited by law.

Personal Information

22. Wheelock Place Management reserves the right to disqualify any entry submitted by a participant/player with fictitious registered details.
23. Wheelock Place Management may:
- h. disqualify any entry containing false or incomplete information; and
 - i. disclose participants/players' personal information to the relevant authorities and publish the names of winners as required by law.
24. Personal information of players provided in registering for the Contest, or otherwise with Wheelock Place Management in relation to the Contest, will be collected and used for several purposes including, but not limited to analytical purposes, sending occasional updates for special promotions, announcements & important updates from Wheelock Place Management (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.

To the maximum extent permitted by applicable law, Wheelock Place Management reserves the right, in its sole discretion, to revise the Terms of the Contest, or revise or cancel the Contest at any time, or to modify, terminate, or suspend the Contest should unauthorized human intervention or other causes beyond Wheelock Place Management's control corrupt or impair the administration, security, and fairness of the entries or for whatsoever reason Wheelock Place Management thinks fit. Wheelock Place Management is not responsible for any human or other error that may occur in the processing of the entries, nor responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, theft or destruction or unauthorized access to, or alteration of, entries nor for any technical, network, telephone, computer, hardware or software, malfunctions of any kind, or inaccurate transmission of, or failure to receive any TERMS AND CONDITIONS / entry information on account of technical problems or traffic congestion on the internet or any web site(s).
26. The Jingle Jangle Jog online game contest is in no way sponsored, endorsed or administered by, or associated with, Facebook and/or Instagram. Any information provided in connection with the Contest will be to the Wheelock Place Management only and not to Facebook and/or Instagram



27. In the event of any dispute, all decisions made by Wheellock Place Management will be final and no correspondences will be entertained thereafter.

Technical Requirements

28. Wheellock Place Management shall not be held liable or responsible for any delay and/or failure in the receipt of entry due to the inability of the respective Internet Service Provider [ISP] company and/or telecommunication network to provide timely and/or efficient internet and/or telecommunication services.
29. Participants/Players also agree that the Wheellock Place Management is not responsible nor liable for any delay, injury or damage to the participant's/player's and/or any third party's computer, computer system or apparatus relating to or resulting from the access to, participation in this Contest, including the playing, downloading of any materials or information from the Contest and in connection with this Contest, submission/uploading of the information/time score for this Contest, including without limitation any server failure, lost, delayed or corrupted data or other malfunction.
30. Wheellock Place Management is also not responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorized access to, or alteration of, user or member communications, or any problems or technical malfunction of any telecommunication network or lines, computer online systems, servers or providers, computer equipment, software, failure of e-mail on account of technical problems or traffic congestion on the Internet and/or telecommunication networks.

Wheellock Place Management reserves the right to modify, suspend or cancel this Contest in the event that it becomes incapable of running as planned, technically interfered or corrupted, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Wheellock Place Management, despite the best efforts of Wheellock Place Management.

Governing Law

32. The Terms are governed by the laws of Singapore and participants agree to submit to the exclusive jurisdiction of the courts of Singapore.

Rights of Third Parties

33. Except for Wheellock Place Management, Everbilt Developers Pte Ltd, its subsidiaries, affiliates, associates, agents and assigns, the Terms are not intended to confer any rights on any third party under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce these Terms.
